The offenses listed below do NOT require a court appearance. Failure to pay will result in your driver's license being CANCELLED, an ARREST WARRANT being issued. If the officer DID NOT WRITE "MUST APPEAR" on your ticket, an appearance is NOT required and the ticket can be paid for \$125.00 unless otherwise listed below.

The Officer will put your court date and time for your court appearance on the bottom of your traffic citation. If you fail to appear an arrest warrant, cancellation of your driver's license and a block on your ability to register a vehicle WILL OCCUR.

PAYMENT OPTIONS

How to pay fines and costs when an appearance is not required:

- 1. Your copy (blue or pink) of the ticket.** Ohio law requires that you sign the guilty plea and waiver of trial on the back at the bottom of your ticket and either bring it to the court or mail it with your payment.
- 2. Payment.** You may pay with cash, check (personal check, cashier check or company check) or money order, Discover, American Express, and MasterCard for the TOTAL amount owed. Visa credit cards are not accepted. If you send less than the total amount your payment will be rejected. Partial payment will not be accepted.
- 3. Payable.** Your check or money order should be made payable to the "Carroll County Municipal Court". DO NOT SEND CASH THROUGH THE MAIL.
- 4. Credit Cards.** Credit cards may be used in person at the court or by phoning the court. Debit cards must be used in person at the court only. Visa debit cards are accepted in person at the court.
- 5. Can't pay in Full.** If you are unable to pay the full amount, then you **MUST** appear in Court on the date and at the time stated on your ticket. You may explain your circumstances to the Judge and ask for time to pay by agreeing to pay monthly.
- 6. Proof of Insurance.** If you did not show the officer proof of insurance when you received the ticket, then you **MUST** show the Court that insurance was in effect at the time of the ticket. Failure to provide proof of insurance **WILL** result in a suspension of your license by the Ohio Bureau of Motor Vehicles. Acceptable forms of proof of insurance include a copy of your insurance card or policy showing the effective dates and the car insured.
