We also request and make application to you to institute and order proper proceedings for below described road; we also attest to the below described road as not being a road on the State Highway System.

BE IT FURTHER RESOLVED that Township Clerk shall file a copy of this resolution with the Board of County Commissioners and certify another copy to County Engineer per the Ohio Revised Code.
